Established in 1964, IÉSEG is France's largest private university, and is currently one of the top ten business schools in France. IÉSEG has two campuses: Lille and Paris, and StFX students can choose to study at either one. The Paris campus opened in 2009 in the heart of the business district of La Défense and is close to a big shopping centre, restaurants, snack bars, cinemas, and an RER metro station. The Lille campus is next to the peaceful Jardin Vauban and within easy walking distance from student residences and the commercial and cultural centre of Lille. Lille is the 3rd student city in France with a vibrant cultural scene and outstanding quality of life. It is the gateway to North-Western Europe with Brussels only 35 minutes away, while Paris is only one hour away.

Course Requirements:	Exchange students are expected to take 30 ECTS credits per semester of study. 30 ECTS credits are equal to 15 credits at StFX. 6 ECTS credits are equal to 3 credits at StFX.
Course Restrictions:	Students in their fourth year at StFX are able to take both undergraduate and master's courses at IÉSEG.

ACCOMMODATIONS		
Type of Accommodation:	On Campus Residence or Off Campus Housing

Cost:	€400 - €1050 per month. (Equivalent to approximately \$600 - \$1580 CAD)	
Details:	IÉSEG will assist students in finding accommodations; however, housing is on a first-come, first-served basis and finding housing on arrival is difficult, so students are advised to register for housing at the time of application. The Paris campus is entirely off-campus housing, however the Lille Campus has two on-campus residences that students can apply for. However spaces are limited so students are encouraged to apply early.	

OTHER COSTS	
Health Insurance:	 All StFX students are required to purchase travel health insurance for the duration of their time abroad. Link Additionally, French Social Security health coverage is mandatory for all students under the age of 28 and covers around 70% of medical expenses. This health coverage is free of charge, and upon arrival, the host university will help you to apply. Please note that you will be required to submit the following documents along with your application: A copy of your complete birth certificate A copy of the long stay visa and the OFII sticker or a valid residence permit A copy of your valid passport French bank account details
Living Expenses:	Link
Visa:	Anyone studying in France for more than three months will need a student visa. You will need to book an appointment at the nearest embassy at least three months prior to the start of your exchange, and then travel to the embassy to submit supporting documents and your valid passport. Students will need to apply for a temporary long-stay visa or VLS-T "étudiant" (up to one year of study). The cost is €99 (~\$150 CAD). Link *Please note that travel to the nearest French consulate or embassy will be required to apply for the long-stay visa.
